- 5.4.1. If your order is delayed, damaged, or incorrect, please contact us within 48 hours of delivery at garden@kynoch.co.za.

6. Returns and refunds

6.1. Eligibility for Returns:

- 6.1.1. Products must be unused, in their original packaging, and returned within 14 days of delivery.
6.1.2. Refunds or exchanges are not permitted for opened or partially used products unless the product is defective.

6.2. Defective or Damaged Items:

- 6.2.1. Any item that is damaged on delivery must be reported and returned within 14 days of delivery.
6.2.2. Any item that is defective must be returned within 6 months of delivery.

6.3. Refund Process:

- 6.3.1. Refunds will be processed once the returned item is inspected and approved.
6.3.2. Refunds will be issued via the original payment method within 14 business days.

In such case, notice shall be deemed given 7 (seven) days after the date of mailing.
